Law 295: Research, Reasoning, Writing, and Advocacy (RRWA) I

RRWA I students write genres addressed to internal audiences, such as office memoranda and client letters. Assessment consists of a quiz, a graded office memo, and a professionalism component. I co-developed this course curriculum.

Law 296: Research, Reasoning, Writing, and Advocacy (RRWA) II

RRWA II students write genres addressed to external audiences, such as motion memos and appellate briefs. Assessment consists of a graded motion memo, an oral argument, and a professionalism component. I co-developed this course curriculum.

Summer Tutorial: Advanced Professional Writing for Lawyers

Online tutorial developed in 2009 with Professor Ruth Ann McKinney of UNC Law. Designed and recorded audio/visual podcasts and writing assignments for law students to complete over the summer for advanced learning in legal writing.

University of North Carolina Department of English and Comparative Literature

English 305: Advanced Writing in Law

Upper-division, genre-based writing course with focus on Constitutional Law. Students lead discussion on one reading assignment during the semester, either a court opinion or a law review article. Written genres include case briefs, an annotated bibliography, and a research article on a legal topic, an abstract, and a cover letter presenting their research. Students submit articles to scholarly journals for possible publication. I designed this course for the UNC Writing Program.

English 102i: Writing in Law

First-year writing in the disciplines (WID) composition course with an interdisciplinary focus on law. Course texts include Supreme Court opinions and excerpts of other foundational texts. Written genres include a rhetorical analysis, a case brief, a research outline, and a research paper. Provided consultation for Graduate Teaching Fellows. I designed this course for the UNC Writing Program and wrote a teacher's manual: TEACHING WRITING IN LAW AT UNC (2009).
